There is a Vigilance information that  
A-1 Tr.K.P.Anbalagan, Formerly Minister  
for Higher Education Department,  
Government of Tamil Nadu during the  
period of his office between 23.05.2016  
and 06.05.2021, involved in corrupt  
activities and intentionally enriched  
himself illicitly and acquired properties  
and pecuniary resources in his name and  
in the names of his family members,  
relatives and others, which are  
disproportionate to his known sources of  
income.

Upon this information, a discreet  
verification was conducted and it  
disclosed the following:

The accused-1 Tr.K.P.Anbalagan is  
native of Keragodahalli Village,  
Karimangalam Taluk, Dharmapuri District.  
He has been residing at 1/136A,  
Keragodahalli (Village & Post),  
Karimangalam Taluk, Dharmapuri District  
and living as joint family with his wife A-2  
Tmt.A.Malliga and sons A-3  
Tr.A.Sasimohan, A-4 Tr.A.Chandramohan  
and daughter-in-law A-5  
Tmt.S.Vaishnavee.

**Accused-5**

Tmt.S.Vaishnavee (Age-32/2022),  
W/o Chandramohan,

The accused-1 Tr.K.P.Anbalagan, S/o. K.T.Pachiyappan (DOB: 30.04.1958) has hailed from a middle class family. He was elected to the Legislative Assembly of Tamil Nadu from 057 - Palacode Constituency, Dharmapuri District on 02.05.2016 and held the post of Hon'ble Minister for Higher Education Department, Government of Tamil Nadu from 23.05.2016 to 06.05.2021. In addition to that, he was holding the post of Minister for Agriculture, Government of Tamilnadu from 01-11-2020 to 06.05.2021. He was elected as Member of Legislative Assembly from Palacode Constituency for five times consecutively i.e., from 2001 to till date. He held the charge of Minister for Municipal Administration, Rural Development Department and Minister for Information of the State between 2001 and 2006. He is a public servant as defined u/s. 2(c) of the Prevention of Corruption Act, 1988.

The discreet verification discloses that the accused-1 Tr.K.P.Anbalagan, during the period from 27.04.2016 to 15.03.2021 and his tenure as Minister for Higher Education Department, Government of Tamil Nadu has acquired and was in possession of immovable and movable assets in his name and in the names of his family members, relatives and others which are disproportionate to his known sources of income and thereby intentionally enriched himself illicitly during the period of his office.

When the A-1 Tr.K.P.Anbalagan filed the affidavits dated 27.04.2016 and 15.03.2021 during the nomination of general election to Tamilnadu Legislative Assembly-2016 and 2021 respectively before the Election Commission of India, he disclosed that he is the Kartha (Head of the HUF) of Hindu Undivided Family. The affidavit discloses the movable and immovable

properties stands in his name and in the name of his wife, sons and daughter-in-law.

The discreet enquiry further discloses that A-1 disclosed the assets such as 50% shares in Sri Bagiyalakshmi Theatre under Hindu Undivided Family, 50% shares in S.M.Blue metals, partnership in SAI Impex and proprietorship of AMPS Enterprises in the name of A-3 Tr.A.Sasimohan. The hospital running under the name and style of Anbu Super Specaility Clinic in the name of A-4 Tr.A.Chandramohan and proprietorship of Sri Bagiyalakshmi Enterprises in the name of A-2 Tmt.A.Malliga. Further A-1 disclosed about the running of a charitable trust under the name and style of Saraswathi Palaniappan Educational and Charitable Trust being managed by his family.

As most of the acquisitive activities had taken place between 27.04.2016 and 15.03.2021, the check period for assessing the disproportionate assets is taken from 27.04.2016 to 15.03.2021. Affidavits filed on 27.04.2016 and 15.03.2021 by A-1 Tr.K.P.Anbalagan during his nomination to general elections of Tamil Nadu Legislative Assembly Election-2016 and 2021 respectively before the Returning Officer and information received from credible sources were taken into account for arriving the quantum of disproportionate assets.

From the above statements, during the check period between 27.04.2016 and 15.03.2021, the value of assets acquired by the accused-1 Tr.K.P.Anbalagan, accused-2 Tmt.A.Malliga, accused-3 Tr.A.Sasi Mohan, accused-4 Tr.A.Chandra Mohan and accused-5 Tmt.S.Vaishnavee have been calculated in Statement-V. The likely savings of the accused-1 Tr.K.P.Anbalagan, his wife Tmt.A.Malliga, sons Tr.A.Sasi Mohan and Tr.A.Chandra Mohan and daughter-in-law Tmt.S.Vaishnavee has been shown in Statement-VI and the quantum of disproportionate assets acquired

by the accused-1 in his name and in the name of his wife Tmt.A.Malliga and sons Tr.A.Sasi Mohan and Tr.A.Chandra Mohan and daughter-in-law Tmt.S.Vaishnavee has been shown in Statement-VII as detailed below.

Statement-V Value of assets acquired by A-1 21,43,35,418  
(St.II - St.I) Tr.K.P.Anbalagan in his name and in the name of his wife A-2, sons A-3 and A-4 and daughter-in-law A-5 during the check period between 27.04.2016 and 15.03.2021.

Statement-VI Likely savings of the accused-1 10,10,39,663  
(St.III - St.IV) Tr.K.P.Anbalagan in his name and in the name of his wife A-2, sons A-3 and A-4 and daughter-in-law A-5 during the check period between 27.04.2016 and 15.03.2021.

Statement-VII The quantum of assets disproportionately 11,32,95,755  
(St.V - St.VI) acquired by the accused-1 Tr.K.P.Anbalagan in his name and in the name of his wife A-2, sons A-3 and A-4 and daughter-in-law A-5 during the check period between 27.04.2016 and 15.03.2021.

As per the above statements, the accused -1 Tr.K.P.Anbalagan, had the likely savings about Rs. 10,10,39,663/- during the check period i.e., between 27.04.2016 and 15.03.2021 and hence, the pecuniary resources and properties acquired by him and in the name of his wife A-2 Tmt.A.Malliga, sons A-3 Tr.A.Sasi Mohan and A-4 Tr.A.Chandra Mohan and daughter-in-law A-5 Tmt.S.Vaishnavee should not have exceeded Rs.10,10,39,663/- during the check period. But he has acquired assets worth Rs.11,32,95,755 more than his total income, which is disproportionate to the known sources of income.

Further information reveals that A-1 Tr.K.P.Anbalagan, runs a Hot Mix Plant and Rough Stone Quarry in S.F.No. 1/1 and S.F. No.333 respectively at Kalappanahalli Village, Karimangalam Taluk, Dharmapuri District in the name of his son-in-law Tr.P.Ravishankar, a Rough Stone Quarry at S.F. No.

335 part, Kalappanahalli Village, Karimangalam Taluk, Dharmapuri District in the name of his brother-in-law Tr.P.Saravanan. Likewise, A-1's brother-in-law Tr.A.Senthilkumar also runs a stone crusher with M-sand unit in the name and style of S.K.Blue Metal at 259-8, Palayam Village, Dharmapuri in the name of his close associate Tr.P.Anguraj.

Further, it is reliably learnt that A-1 runs a granite factory in the name and style of M/s. Ganesh Granite having its office at Door No.374, Avvai Shanmugam Salai, Gopalapuram, Chennai in the name of his sister's daughter Tmt.Deepa and her son-in-law Tr.N.Sivakumar. It is also learnt that Tr.N.Sivakumar holds 80% shares in M/s. Sri.Vaishnavi Granite Industries having its office in Bhagyanagar at Door No.2-1-2061/1, Karimnagar, Telangana State.

Further it is learnt that A-1 had acquired many more assets in his name and in the names of his family members, relatives and associates which are disproportionate to his known sources of income in various places in and around Tamil Nadu and outside.

The above information clearly discloses that during the check period between 27.04.2016 and 15.03.2021, the accused-1 Tr.K.P.Anbalagan was found in possession of pecuniary resources and also intentionally enriched himself illicitly during the period of his office, which constituted the offences of Criminal Misconduct punishable U/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 for the period between 27.04.2016 and 25.07.2018 and u/s 13(2) r/w 13 (1) (b) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 for the period between 26.07.2018 and 15.03.2021. A-2 Tr.A.Malliga, A-3 Tr.A.Sasi Mohan, A-4 Tr.A.Chandra Mohan and A-5 Tmt.S.Vaishnavee abetted and intentionally aided A-1 Tr.K.P.Anbalagan to acquire pecuniary resources and to enrich him illicitly which is constituted the offences punishable u/s 109 IPC r/w 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 for the



period between 27.04.2016 and 25.07.2018 and u/s 12 r/w 13(2) r/w 13 (1) (b) of the Prevention of Corruption Act, 1988 by the Prevention of Corruption (Amendment) Act 2018 for the period between 26.07.2018 and 15.03.2021.

Hence, I am registering a case in Dharmapuri V&AC Cr.No.03/AC/2022 u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 for the period between 27.04.2016 and 25.07.2018 and U/s 13(2) r/w 13(1) (b) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 for the period between 26.07.2018 and 15.03.2021 against the accused-1 Tr.K.P.Anbalagan and U/s. 109 IPC r/w 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 for the period between 27.04.2016 and 25.07.2018 and u/s 12 r/w 13(2) r/w 13 (1) (b) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 for the period between 26.07.2018 and 15.03.2021 against A-2 Tmt.A.Malliga, A-3 Tr.A.Sasi Mohan, A-4 Tr.A.Chandra Mohan and A-5 Tmt.S.Vaishnavee on 19.01.2022 at 14.45 hours.

The original FIR is submitted to the Hon'ble Special Judge / Chief Judicial Magistrate, Dharmapuri and a copy of FIR is going to be sent to the Superintendent of Police, Western Range, Directorate of Vigilance and Anti-Corruption, Chennai for issuing orders U/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of Prevention of Corruption Act, 1988 to inspect Bankers Books relating to the accounts of the accused and other suspected persons in the case.
